



## GENERAL RENTAL CONDITIONS 2025

### PITCHES

#### 1 - Inscription

All inscriptions should be accompanied by the payment of 80 euros (down payment) and the reservation cost of 23 euros.

#### 2 - Duration of the stay

Between the 5th July and the 23th August, for better management and in the interest of our clients, the duration of your stay must be 15 days minimum. Arrivals are asked to arrive here after 3pm and departures to leave before 12pm.

#### 3 - Reservation

Your final reservation will be confirmed by the campsite by post or by e-mail. You will have to pay the final balance of your holiday on arrival at the campsite. Any modifications should have been notified before you arrive.

#### 4 - Number of participants

The number of participants cannot be modify without writing agreement of the camping. The camping can refuse those people, included children.

#### 5 - Cancellation of the stay

##### 1. Modification of your reservation :

Any modification concerning your booking can be made without fees, subject to availabilities. All modification regarding the dates of your stay must be hand-written and only for the current year. Without message from you indicating a report of your date of arrival, the mobil-home or the pitch can be rented again 24 hours after the date of arrival mentioned on the contract, therefore you will lost the benefit of your reservation.

##### 2. Services not used :

Any stay suspended or shorten (late arrival, early departure) decided by yourself cannot be reimbursed.

##### 3. Cancellation due to the camping :

In case of cancellation due to the camping, except in case of force majeure, the stay will be completely reimbursed. However, this cancellation cannot give rise to payment of damages.

##### 4. Cancellation due to the client :

Any cancellation of a booking must be made in writing (with proof of delivery) at your campsite. The reimbursement is made after deduction of the amounts which are below:

More than 30 days before the date of the beginning of the stay: the deposit paid will be kept by the campsite.

Less than 30 days before the date of the beginning of the stay: 100% of the amount of the stay will be kept by the campsite.

#### 6 - Pets

(1 animal per pitch)

Your pet is permitted except 1st and 2nd categories on the site on a lead, following the presentation of their vaccination certificate and their identity number.

#### 4 - Number of participants

The number of participants must correspond to the number of people indicated on the booking form, included children.

The camping can refuse people who are too many.

#### 5 - Cancellation of the stay

##### 1. Modification of your reservation

Any modification concerning your booking can be made without fees, subject to availabilities and only for the current year.

All modification regarding the dates of your stay must be hand-written.

Without message from you indicating a report of your date of arrival, the mobil-home or the pitch can be rented again 24 hours after the date of arrival mentioned on the contract, therefore you will lost the benefit of your reservation.

##### 2. Service not used

Any stay suspended or shorten (late arrival, early departure) decided by yourself cannot be reimbursed.

##### 3. Cancellation due to the camping :

##### 4. Cancellation due to the client :

Less than 30 days before the date of the beginning of the stay: 100% of the amount of the stay will be kept by the campsite.

#### 6 - Caution

At the beginning of your stay, you will be asked to pay a deposit of 300 euros. This deposit is taken as a precaution, and is returned to you assuring that you have not damaged the mobile home or left it untidy at the end of your stay. Deductions will also be made, if there is anything found missing. The cleaning of the mobile home is the responsibility of the tenant. At the end of your stay you must ensure the mobile home is clean, if it is not clean enough a minimum of 70.00 € will be deducted from your deposit.

#### 7 - Pets

(1 animal per pitch)

Your pet is permitted only after autorisation from direction, except 1st and 2nd categories onto the site on a lead, following the presentation of their vaccination certificate and their identity number.

Pets must not be left alone on the pitch or in the mobil-home.

### GENERAL RULES

#### 1 - Rules inside the Campsite

In order to ensure you a pleasant stay, rules on the campsite are available from the campsite reception. Taking time to get to know the rules in order to respect them would be appreciated.

#### 2 - Responsibility

SAS SOGEVEN will not take any responsibility regarding items stolen, lost or damaged of any nature, during or after your time here on the campsite.

The management is only responsible for the objects deposited at the reception. Personal luggage insurance is obligatory.

#### 3 - Local Taxe

Tax de séjour is put in place by the municipalities, is not included in our tarifs.

#### 4 - VAT

Our prices are inclusive of French TVA at 10%. However, should this be increased, you will be asked to pay the difference.

#### 5 - Information

More information will be provided about the campsite on your arrival.

The management have the right, to change any of the services indicated.

#### 6 - Holidays cancellation

The campsite offers you optional Cancellation and Interruption insurance in your rental contract. Our partner Gritchen Affinity will refund all or part of the stay only to customers that have purchased Campeze Couvert insurance.

In case of cancellation, please notify the campsite of your cancellation as soon as an event occurs that prevents your departure, by letter or by email. If the claim is covered in the general conditions (available at [www.campeze-couvert.com](http://www.campeze-couvert.com) or from the campsite), please notify the insurer within 48 hours and provide all the necessary information and supporting documents.

#### 7 - Aquatic space

Shorts are not allowed at the swimming pool

#### 8 - Image

Information that you communicate to the camping during your reservation don't be given to any third party. These information will be considered by SAS SOGEVEN – Camping les Dunes as confidential. They will be used only by our services, for your booking and to reinforce, personalize communication and services offered to clients depending on your hobbies and interests.

#### 11 - Terms of sponsorship

### MOBIL-HOME

#### 1 - Inscription

All inscriptions should be accompanied by the deposit of 25% of the cost of your mobile home and the reservation cost of 23 euros.

#### 2 - Duration of the stay

Between the 5th of July to 30th of August 2025 the minimum duration of your stay is one week. The day of arrival is specified on reservation (Saturday, Wednesday or Sunday). The availability of the dates of your stay will be confirmed. Arrivals are done between 4pm and 8pm (if you are going to be later, please let us know). Departures are from 7am until 10am (at the latest).

#### 3 - Reservation

Your final reservation will be confirmed by the campsite by post or by e-mail. You will have to pay the total cost of your stay here, 30 days before your arrival date. If this not done, the reservation could be considered cancelled and we will keep the deposit that you have paid.
